Spring Yard Sale JAMBOREE: The Yard Sale hours will be 10:00am -2:00pm on Saturday, April 6, 2024. The Yard Sale jamboree is an outside show that will be held at the Conway Recreation Center lot, located at 1515 Mill Pond Road in beautiful Conway, South Carolina. This outside event is provided to vendors offering quality arts/craft and commercial items a location to sell their products or to promote their business. This shopping event features specialty merchants from across the country offering unique gift items. This includes merchants selling everything from clothing, jewelry, and handbags to specialty gift food, art, crafts and children's items.

- <u>APPLICATION PROCESS</u>: Submission of this application does not guarantee a space. Applicants must submit (with application) at least two (2) photos of the items that will be available for sale in their booth. No application will be accepted without the complete application, photos and fee. If your application is not approved, your check will not be cashed and it will be returned. Once you have been accepted as a vendor, NO REFUNDS will be issued for *any reason*. <u>Application deadline is</u> <u>April, 1 or until spaces are full</u>. A confirmation will be sent via email or mail.
- <u>RESTRICTED ITEMS</u>: Food and beverage items such as sandwiches, soft drinks and water may not be sold. Specialty food gift items will be approved on a case by case basis. Music may not be played from individual booths. We reserve the right to remove any items that have not been screened, are of poor quality or inappropriate. <u>The following items are banned from sale</u>: Any type of animal or pet, snap-N-pops, cap guns or rockets, disappearing ink, crazy foam or silly string, stink bombs, water and marsh mellow guns, knives, guns and/or any other weapons (*including replica weapons*).
- 3. <u>SPACE ASSIGNMENTS</u>: Spaces are 10' x 10'. Booths will be assigned in advance. Exhibitors will not be able to extend beyond the 10' x 10' space. Isles must be clear at all times. Staff will be on hand to assist with any questions you may have. If you need more than the allotted 10' x 10' space for display, you must purchase another space in advance. Spaces may not be sublet.
- 4. <u>BOOTH APEARANCE</u>: All booth should be attractive. Tables must be covered and draped to the floor. Boxes and overstock should not be visible at any time. Please keep your display neat and free of trash. Vendors must bring all necessary displays, tables, and chairs
- 5. <u>SET UP:</u> Vendors may begin their set up on Saturday from 7:00am to 9:45am. All set up must be completed no later than 9:45am on Saturday, if you arrive late your space may not be available. Set up is not allowed after the event has started.
- 6. NO OPEN FLAMES, NO SMOKING and NO PETS allowed.
- 7. <u>CLEAN UP:</u> You are expected to leave the area you occupy as you found it prior to set up. Please dispose of your trash in the provided trash cans.
- 8. <u>NO EARLY BREAK DOWN:</u> The breakdown of displays and vendor booths is not allowed **until the Jamboree closes at** 2:00pm.
- 9. <u>NOTICE</u>: Conway Parks and Recreation reserves the right to ACCEPT or REJECT any application. We also reserve the right to remove any vendor that does not follow the rules and regulations as established for this event.
- 10. TAXES: As the vendor, you are responsible for collecting and reporting South Carolina sales tax as required by law.
- 11. <u>NO SHOWS:</u> Vendors accepted into the Spring Yard Sale who fail to participate without giving a 48 hour written notice shall NOT be eligible to participate in future shows promoted by Conway Parks and Recreation.
